#### 4. First aid measures

### 6. Accidental release measures

**Environmental precautions**

#### Methods for cleaning up

**Small spill**

# 7. Handling and storage

**Handling**

# 8. Exposure controls/personal protection

Dry sanding, flame cutting and/or welding of the dry paint film will give rise to dust and/or hazardous fumes. Wet sanding/flatting should be used wherever possible. IARC has issued a notice that they will publish a monograph that lists titanium dioxide (TiO2) as possibly carcinogenic to humans (Group 2B) by inhalation (based solely on animal data). Human epidemiology studies do not suggest an increased risk of cancer in humans for occupational exposure to titanium dioxide. According to the IARC summary on titanium dioxide, "No significant exposure to titanium dioxide is thought to occur during the use of products in which titanium dioxide is bound to other materials, such as paint."


